Objectives/Aims


- A comprehensive research programme on citizens' attitudes towards welfare policies across European countries
- Focus on the interactions between individual welfare attitudes and behaviour, institutional contexts and structural variables
- Input to the interdisciplinary field of comparative studies of welfare state attitudes
- Critical insights for the public legitimacy of welfare state reform
- The effects of different forms of diversity: ethnic, social, institutional

What is added?

Analyses that...

- combine individual-level attitudinal data with country-level data on the institutional set-up of welfare policies;
- are more firmly based in welfare state theory;
- more clearly specify the relevant dependent variables that may reveal variations between different institutional and cultural environments;
- use data that are comparable across a larger number of countries.

- Comparative study of welfare state professionals (fielded 2009)
- ISSP 1990, 1996, 2006
- National surveys of welfare attitudes
- European Data Centre for Work and Welfare (EDAC) – macrodata

Methods

- Various versions of multi-level models (HLM)
- Not all substantive eggs in the same methodological basket
